About

The **Family Mediation Certification Programme (FMCP)** is open to all Singapore Mediation Centre (SMC) Accredited Mediators. FMCP is a joint effort between SMC and the Family Justice Courts. This five-day intensive certification programme will take place from **13 to 16 October 2025***, with an assessment on **14 November 2025**. This programme is designed to enhance a mediator's skills in managing family disputes. Participants will acquire practical knowledge on handling family mediation cases, which includes how to manage issues such as custody of children, matrimonial asset division, the psychology of family dynamics and family violence.

To be accredited as an SMC Certified Family Mediator, participant must pass the Family Mediation Certification Assessment. The Participant will not, however, be placed on SMC's Family Panel* nor assigned cases by SMC**.

→ NOTE

In the event that the programme is unable to proceed on the published dates, it shall be rescheduled to a later date and advance notice will be provided.

Those who passed the Family Mediation Certification Assessment and wish to be empaneled on the SMC's Family Panel must sign up and meet the following requirement to be empaneled on the SMC's Panel of Mediators:

- obtain a distinction in SMC's Mediation Skills Assessment (MSA) and;
- successfully complete the interview stage.

**Those already on SMC's Panel of Mediators will automatically be empaneled on the SMC's Family Panel upon passing the Family Mediation Certification Assessment. The SMC does not guarantee the assignment of cases.

ANGELINA HING

Judge Wong Sheng Kwai has been an advocate and solicitor of the Supreme Court of Singapore since 1989. Prior to his appointment as District Judge and Assistant Registrar of the Family Justice Courts in 2010, he held various positions in the Singapore Public Service including:

- Assistant Official Assignee/Official Receiver/Public Trustee
- District Judge of the Subordinate Courts (now the State Courts) and
- Deputy Director, Legal Aid Bureau

Sheng Kwai is currently serving as a Judge Mediator at the Family Justice Courts and is an accredited Family Mediator with the Singapore Mediation Centre.

SOPHIA ANG

Sophia Ang is the Senior Director of the Counselling and Psychological Services (CAPS) at the Family Justice Courts (FJC). Sophia provides strategic direction for the mental health and social science related services within FJC. She leads a professional team of court psychologists, social workers, and counsellors to provide custody related assessments and counselling services for litigants and their families undergoing various legal proceedings in the FJC. In 2011, she helped conceive the Child Focused Resolution Centre, which provides mandatory mediation and counselling in FJC. Sophia's professional affiliations include being a registered counsellor and clinical supervisor with the Singapore Association of Counselling (SAC), a full member of Singapore Psychological Society, Principal Mediator and Family Mediator with the Singapore Mediation Centre, and a SIMI-Certified Mediator with the Singapore International Mediation Institute.



LOONG SENG ONN

Loong Seng Onn served as an officer of the Singapore Mediation Centre (SMC) for over 2 decades, taking on the role of Executive Director from 2004 to 2019. As Executive Director, he was instrumental in the strategic development of SMC and oversaw its day-to-day operations. Seng Onn is on the panel of mediators for both SMC and the Singapore International Mediation Centre. He is also a CEDR UK, IMI (International Mediation Institute), and SIMI (Singapore International Mediation Institute) accredited mediator and a gazetted mediator for the Tribunal for the Maintenance of Parents. Seng Onn is an experienced dispute resolution trainer, where he led the SMC's training work as well as managed a faculty of trainers, coaches, and assessors. He has been involved as the lead instructor for many conflict management workshops both locally and internationally.



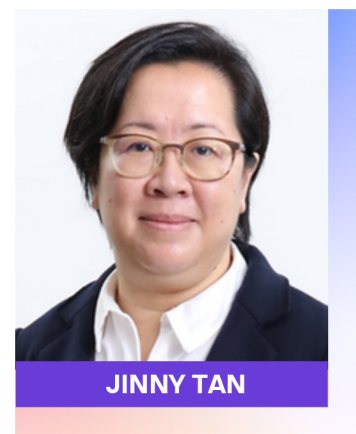
Special Thanks

District **Judge Kevin Ng** is the Senior Judicial Head of the Family Dispute Resolution Division at the Family Justice Courts (FJC). Since 2005, Kevin has focused on the area of amicable dispute resolution in family matters. In 2006, he helped conceive and set up the FJC's Family Resolutions Chambers which focused on family mediation. In 2011, he co-designed and established the Child Focused Resolution Centre, which was specifically designed to assist parents and children involved in divorce proceedings.

These departments, together with the Counselling and Psychological Services, are known as the Family Dispute Resolution Division today. The Division handles the provision of counselling, mediation and upstream Therapeutic Justice services in FJC. Kevin also oversees the therapeutic and forensic support schemes of FJC, including the Child Representative (lawyer for the child), Parenting Coordination, Panel of Therapeutic Specialists, along with the Volunteer Mediator and Family Neutral Evaluation programmes.

He has been accredited as a mediator by the Singapore Mediation Centre, the Singapore International Mediation Institute and the Centre for Effective Dispute Resolution. Kevin received Singapore National Day awards for his work in 2010 and 2020.

Jinny Tan has been an advocate and solicitor of the Supreme Court of Singapore since 1998. Jinny was in practice, dealing with a broad spectrum of matters, ranging from matrimonial law to civil and commercial litigation. She joined the Family Justice Courts in 2015 as a District Judge and Assistant Registrar. In 2020, she became a full time Judge-Mediator. Jinny is an accredited Family Mediator with the Singapore Mediation Centre.
